

# **This is St John & St James CE Primary School Publication Scheme on information available under the Freedom of Information Act 2000**

*The governing body is responsible for maintenance of this scheme*

## **1. Introduction: what a publication scheme is and why it has been developed**

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form and from time to time available on our website.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

## **2. Aims and Values**

St John & St James Church of England Primary School is a voluntary, Religious Foundation of 150 years standing. We value greatly the school's unique Christian identity and character and its historic and contemporary contribution to the parish and the local community.

We believe that our attitudes to all educational, spiritual, social and moral questions should be based on the teachings of the Christian Faith and that this should shape and guide all aspects of the school's daily life. In a time of rapid change and uncertainty, we are committed to maintaining those values that we believe to be essential in helping our pupils to live responsible, satisfying, positive and caring lives, now and as adults and members of the community.

The school aims to:

- Provide an education of the highest standard for all pupils regardless of ability, special needs, physical ability, gender, culture or ethnic origin
- Create a positive learning environment that enables all pupils to realise their full potential in all areas of the curriculum and to ensure that all pupils have equal opportunities to succeed
- Provide a secure, happy and caring environment in which all pupils feel valued and are safe from the effects and threat of bullying, racial abuse and discrimination

- Encourage in our pupils respect for others, good manners, provide in work and a sense of social responsibility for the whole community
- Teach our pupils the value of teamwork and the social skills that will enable them to work effectively and co-operatively with others in all areas of life
- Develop a clear sense of right and wrong in all pupils, firmly based on Christian principles
- Teach our pupils to value and respect everyone equally and to celebrate the cultural diversity of our community
- Encourage the pupils of St John and St James to become wise trustees of the earth's resources and environment and to mature into responsible, courageous and proactive members of the community
- Provide our pupils with a firm education in the Christian faith in hope that one day they will make it their own and that this will provide them with the solid foundation needed to help them meet the demands, uncertainties and challenges of life in a new millennium.

and this publication scheme is a means of showing how we are pursuing these aims.

### **3. Categories of information published**

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

- *School Prospectus* – information published in the school prospectus.
- *School Profile and other information relating to the governing body* – information published in the School Profile and in other governing body documents.
- *Pupils & Curriculum* – information about policies that relate to pupils and the school curriculum.
- *School Policies and other information related to the school* - information about policies that relate to the school in general.

Curriculum Policy	Statement on following the policy for the secular curriculum subjects and religious education and schemes of work and syllabuses currently used by the school
Sex Education Policy	Statement of policy with regard to sex and relationship education
Special Education Needs Policy	Information about the school's policy on providing for pupils with special educational needs
Accessibility Plans	Plan for increasing participation of disabled pupils in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled pupils.
Race Equality Policy	Statement of policy for promoting race equality
Collective Worship	Statement of arrangements for the required daily act of collective worship

Complaints procedure	Statement of procedures for dealing with complaints
Performance Management of Staff	Statement of procedures adopted by the governing body relating to the performance management of staff and the annual report of the head teacher on the effectiveness of appraisal procedures
Staff Conduct, Discipline and Grievance	Statement of procedure for regulating conduct and discipline of school staff and procedures by which staff may seek redress for grievance
Pay Policy	Statement of the school's policy regarding teachers' pay including procedures for determining teachers' grievances in relation to their pay.
Staffing Structure Implementation Plan	The school's plan for the implementation of any changes to its staffing structure following statutory review.
